1. **Schut's Unit Step Ltd** shall provide materials, products and services ("Products") pursuant to its general Purchase Order procedures from time to time or pursuant to such terms as may apply specifically to the Customer or to the particular Purchase Order from time to time.
2. Unless otherwise agreed in writing by **Schut's Unit Step Ltd**, all invoices are due immediately upon delivery of such invoice.
3. Interest shall be charged and paid at the rate of 1 ½% per month (19.6% per year) from the Invoice date on all accounts outstanding after 30 days from the Invoice date.
4. Use of Products constitutes acceptance of them and no claims will be made or allowed after such acceptance.
5. Any damage or deficiency with respect to the Products must be reported to **Schut's Unit Step Ltd** immediately upon receipt it consideration for replacement or adjustment is to be considered.
6. The Customer shall pay a deposit on all wooden pallets. The deposit shall be returned to the Customer for each pallet returned to **Schut's Unit Step Ltd** in good condition suitable for resale.
7. The Customer will pay a restocking charge of 10% for standard Products returned for credit in good condition suitable for resale as new and with a copy of the Purchase Order or Invoice. Return of special order Products must be agreed in writing at the time of the Purchase Order.
